

KIDS launches free suite of resources to support families with disabled children who will use personal budgets, commissioners and others in children's services.

Today KIDS launches a new suite of resources to support families and carers of disabled children who will be using the new personal budgets.

KIDS works with disabled children, young people and their families. As part of the 'Making it Personal' project, sponsored by the Department for Education, KIDS has worked with a number of partners to develop a new suite of resources to explore how personal budgets can be used to their best advantage.

OPM, Disability Rights UK, In Control, NAFIS and the Daycare Trust have worked together with KIDS to develop guidance for commissioners and others in children's services on how to commission for personalisation, along with a handbook for parents and carers of disabled children on what personal budgets are and how they can be used.

This work was developed in response to the Department for Education's Green Paper Support and Aspiration: A new approach to special educational needs and disability (DfE 2011)

"To give parents confidence by giving them more control over the support their family receives, we will introduce more transparency in the provision of services for children and young people who are disabled or who have SEN. Parents will have real choice over their child's education and the opportunity for direct control over support for their family. We propose the option of a personal budget by 2014 for all families with children with a statement of SEN or a new 'Education, Health and Care Plan', many of whom will have complex support needs. Key workers will be trained to advise families and help them navigate the range of help available across health, education and social care."

KIDS' vision is a world in which all disabled children and young people realise their aspirations and their right to a community which includes them and their families. www.kids.org.uk.

KIDS is a charity that was established in 1970 by John Mulcahy, a teacher who became concerned about the development of a disabled child in one of his classes. John wanted to improve communication with this child and sought guidance from the child's mother.

His approach established the KIDS ethos of working in partnership with parents and carers to enable disabled children and young people to develop their skills and abilities – and to fulfil their potential, hopes and aspirations. Forty years on, this is still the basis of our work, though the charity has grown substantially since the initial holidays it provided in the 70s, and now delivers a range of services for all disabled children and young people up to the age of 25 across England.

KIDS has been at the forefront of developing services for disabled children and young people throughout its history (see below for more information about our work). We are proud to have introduced Portage to England several decades ago, but our pioneering work continues. Two years ago KIDS launched a web site through which parents and carers can book short breaks for disabled children and young people in England – www.directshortbreaks.org.uk – the first of its kind.

In addition to working directly with thousands of children, young people and their families each year, KIDS now also works with professionals in this field to provide resources, training and best practice examples to help them to work inclusively.
